## Harbours and Ports Ordinance 2017 section 5

#### **Appointment of Deputy Harbour Master**

#### **Appointment of Inspector of Ships**

- 1. Section 238(1) of the Maritime Ordinance 2017 ("the Ordinance") provides that the Governor may appoint any person as an inspector of ships.
- 2. In exercise of my powers under section 238(1) of the Ordinance, I appoint **Steuart Christopher Barlow** to be an inspector of ships for the purposes of the Ordinance.
- 3. As inspector the appointee must:-

- 4. This appointment takes effect from the date of signature, and continues whilst the appointee is a Departmental officer in the Falkland Islands Maritime Authority, unless terminated sooner.

## Falkland Islands Constitution Order (SI 2008/2846) section 89

#### Appointment of Acting Judge of the Supreme Court

- 1. I make the following appointment in accordance with section 89 of the Constitution, on the basis that:-
  - (a) it appears to me that the state of business in the Supreme Court requires it; and
  - (b) I am satisfied that **Malcolm Howard Simmons** possesses such legal qualifications and experience as are appropriate for him to be appointed.
- 2. I, David Paul Morgan, Acting Governor, appoint Malcolm Howard Simmons:-
  - (a) to sit as Acting Judge of the Supreme Court; and
  - (b) to discharge the functions in the Falkland Islands of the Chief Justice as maybe necessary if the office of the Chief Justice is vacant, or if the holder of that office is for any reason unable to perform the functions of that office.
- 3. The appointment at paragraph 2(a) only has effect when the Chief Justice has not indicated that he wishes to exercise his powers in respect of any relevant matters.

- 4. Nothing in this appointment operates to prevent the Chief Justice adjudicating in any matters or from exercising any of his functions.
- 5. This appointment is effective from 21 February 2022 until the expiry of the contract of employment of **Malcolm Howard Simmons** as Senior Magistrate of the Falkland Islands, unless terminated sooner.
