Retail Prices Index

The Retail Prices Index for the quarter ended 30 September 2022 has now been completed.

The Index has increased by 2.3% to 113.778. The change in the Index over the year to 30 September 2022 has been +6.1%.

The data points to a substantial increase in price growth compared to previous quarters; much of the year-over-year growth is attributed to sustained price growth in fuel (including vehicle fuel and power) in addition to food and nonalcoholic beverages.

Evidence of inflation in the "food and non-alcoholic beverages" category is again observed for quarter 3 of 2022, continuing the trend witnessed over the last three quarters. Changes in prices in this category for the current quarter contributed +0.8 percentage points to quarterly inflation, and +2.1% to annual inflation.

"Fuel and power" contributes +0.6 percentage points to quarterly inflation and +1.4 percentage points to annual inflation (vehicle fuel is included under "transport", rather than "fuel and power"). While kerosene prices have remained largely constant over the last year, diesel prices continue to rise sharply; far exceeding those observed over the last three years. Diesel fuel contributed +0.3 percentage points to quarterly inflation and +1.3 percentage points to annual inflation.

In contrast to the previous quarter, where negative price growth within the core inflation rate had a deflationary effect on headline inflation, prices increased across the "all other items" category during quarter 3; contributing +0.6% to the quarterly change in inflation.
