section 238

Appointment of Surveyors of Ships – Falkland Islands

Background

1. A Memorandum of Understanding concerning maritime administration in the Falkland Islands was made with the Department of Transport and the Government of the Falkland Islands on 1 December 2005.

2. Under the terms of the memorandum, surveys of ships relating to the maritime administration in the Falkland Islands may be undertaken by surveyors from the Maritime and Coastguard Agency, (“MCA”).

Appointment

3. Section 238(1) and (2) of the Maritime Ordinance 2017 (“the Ordinance”) provide that the Governor may appoint persons to be inspectors and surveyors of ships respectively; for the purposes of the Ordinance.

3.1 Section 238(3) provides that surveyors of ships may be appointed either as a ship surveyor or as an engineer surveyor or as both.

3.2 Section 238(4) provides that surveyors of ships may be appointed either generally or for any particular purpose.

4. I, **Alison Mary Blake CMG**, Governor of the Falkland Islands, in exercise of my powers under section 238 of the Maritime Ordinance 2017:–

(a) revoke all previous appointments of surveyors of ships made under section 4(2) of the Merchant Shipping Ordinance 2001 in connection with the Memorandum of Understanding made with the Department of Transport and the Falkland Islands Government on 1 December 2005; and

(b) appoint and authorise any surveyor of the MCA of the United Kingdom to conduct statutory ship and engineering surveys and sign statutory ships documents on its behalf subject to that surveyor:-

(i) already being appointed under sections 256(2) and 256(6) of the UK Merchant Shipping Act 1995; and

(ii) being authorised under the MCA's Surveyor's Marine Surveyor Development Scheme for the intended type and class of survey.

5. MCA will charge and recover survey fees directly from the customers at MCA's specified hourly rate in accordance with MCA policy and agreements with HM Treasury.

6. This appointment takes effect from the date below and continues in effect until it is revoked.
