## Overview

Everyone arriving in the Falkland Islands, whether travelling by sea or air, is subject to a number of requirements, including a 10-day period of quarantine, in accordance with the Infectious Diseases Control (Coronavirus, International Travel, Operator Liability and Quarantine) Regulations 2021. The Regulations came in to force on 8<sup>th</sup> August 2021 and replace the Regulations made in February 2021. The Regulations can be found at <https://www.legislation.gov.fk/view/html/inforce/2021-08-18/fisl-2021-16>

Pursuant to the Regulations, a person must provide information about themselves, about their journey and about the arrangements they have made to stay in quarantine. The information must ordinarily be provided 72 hours before arrival in the Falkland Islands.

The purpose of quarantine is to prevent the inadvertent transmission of coronavirus (also known as Covid-19). Coronavirus is an infectious disease caused by the SARS-CoV-2 virus.

The Falkland Islands has so far been successful in limiting the spread of coronavirus because of the measures in place to reduce the risk of coronavirus being inadvertently transmitted by those arriving from overseas. Quarantine is a key part of those measures. There are some very limited exemptions from the requirement to quarantine which strike a careful balance between managing the risk of infection and the need to maintain key services.

Vessel crews and passengers may be eligible for a reduction in quarantine to 5 or 8 days by utilising a “test to release” option. In the case of vessels, all crew and passengers on a vessel will be treated as being in quarantine together (sometimes referred to as a single ‘bubble’), and any reduction will be based on all persons onboard meeting the applicable vaccination and test criteria for exemptions.

## Access to medical care for vessels with suspected or confirmed cases of COVID -19 on board

The King Edward Memorial Hospital (KEMH) in Stanley can provide a limited range of medical treatments for people who need hospital care if they are ill with Covid-19. Due to emergency aero-medical evacuation restrictions, the KEMH is unable to provide medical evacuation (medevac) to people who are Covid-19 positive to receive hospital treatment overseas. Because of this, and the need to protect limited hospital resources, the Falkland Islands Government may prohibit vessels from entering local ports<sup>1</sup>.

For this reason

- All vessels with suspected or confirmed Covid-19 cases aboard who are travelling to the Falkland Islands should, where possible, seek medical advice and assistance elsewhere.

- Vessels where cases emerge during their time in Falkland Islands territorial waters should immediately seek advice from the Chief Medical Officer.
- Ships' operators should be aware that the vessel may be advised to transit elsewhere so the best medical care can be provided. This will be dependent on the size of the crew, the number of infected persons, the crew vaccination record, the reason for entering the territorial waters and other support available to the vessel.

## **Quarantine Regulations and shipping**

### **Requirements**

A person who arrives in the Falkland Islands must stay in quarantine for a period of 10 days, except in the case of limited exemptions. Time onboard a vessel at sea may count towards these 10 days in certain circumstances. This includes time spent within territorial waters.

The three main exemptions for persons arriving by sea from the requirement to spend any time in quarantine in the Falkland Islands are as follows:

- the person arrives from Ascension Island, British Antarctic Territory, South Georgia and the South Sandwich Islands, St Helena, or Tristan da Cunha, and has spent at least 10 days in that territory, including time at sea; or
- the person arrives on a clean vessel.

“Clean vessel” means a vessel that —

- a) has been at sea for more than 10 consecutive days;
  - b) during the period at sea has not arrived in any place other than Ascension Island, British Antarctic Territory, South Georgia and the South Sandwich Islands, St Helena or Tristan da Cunha;
  - c) during the period at sea has not reported any person as showing symptoms of coronavirus; and
  - d) during the period at sea has only been boarded by persons from, and passengers or members of the crew have only boarded, other vessels that meet the criteria in paragraphs (a)-(c).
- the person disembarked from a vessel arriving in the Falklands where the person also departed from the Falkland Islands, and the following criteria are met:  
since the person's departure —
    - a) The vessel has only been boarded by persons from a clean vessel;
    - b) The passengers or members of the crew of vessel have only boarded another clean vessel;
    - c) No person on board vessel has been reported as exhibiting any symptom of coronavirus; and
    - d) The passenger either —
      - a. was in quarantine in accordance with the Regulations immediately before embarking on vessel or



- b. immediately before embarking was not required to stay in quarantine and had not exhibited any symptom of coronavirus for at least 10 days.

### **Quarantine on board a vessel**

A person may quarantine on board a ship in the Falkland Islands.

Time spent at sea will count towards a period of quarantine if, other than having been at sea for more than 10 days, the relevant vessel meets the rest of the requirements of a clean vessel. Time spent “at sea” includes time spent in the territorial waters of the Falkland Islands.

If persons are in quarantine on a ship in the Falkland Islands, no other person may board the ship during the period in which any person on the ship is in quarantine. The ship’s Master should inform any vessel approaching that the ship is in quarantine, and should ensure no person is allowed to board the ship. If any person boards the ship then the period of quarantine is reset to 10 days for the vessel and all persons on board.

The following persons are exempt from this requirement, when required to board a ship in the course of their duties:

- (a) the Coroner or a Coroner’s officer;
- (b) a customs officer;
- (c) an immigration officer;
- (d) a fire fighter;
- (e) a maritime pilot or maritime accident investigator;
- (f) a medical officer;
- (g) any police officer.

In this instance the person boarding the ship and all persons already on board the ship must follow any measures as specified by the Chief Medical Officer in order to reduce the risk of the spread of Coronavirus.

### **Quarantine Ashore**

Passengers arriving by sea may complete all of their quarantine on the ship on which they arrive, or may move ashore to complete their quarantine at any point after starting quarantine on the vessel. On disembarkation from the vessel, passengers must either travel to their quarantine accommodation in government-designated transport or, if using a private vehicle, they must either travel alone or only with another person who is required to quarantine for the same period.

Visitors and people working for private companies should find their own place of quarantine ashore if not quarantining on their vessel.



## Test to release

There is a “test to release” option under which persons arriving by sea may be able to complete quarantine early, on day 5 or day 8 of their quarantine period, depending on vaccination status, and the vessel’s ability to undertake a testing programme.

In relation to potential early release on day 5, all persons in quarantine onboard the vessel must meet the vaccination and testing criteria, for any person onboard to be granted a reduction in the period of quarantine. In relation to potential release on day 8, all persons must meet the testing criteria.

If any persons disembark the vessel to complete their quarantine ashore after starting quarantine onboard, those ashore and those remaining onboard are still classed as a single ‘bubble’ for the purposes of test to release.

If a vessel is to participate in a test to release programme, the vessel must have sufficient tests for all persons who intend to undertake all or any part of the period of quarantine onboard. A test means a SARS-CoV-2 antigen rapid qualitative test, also known as an LFD or lateral flow test, of a type recognised by Public Health England (PHE).

The tests must be administered either by the ship’s doctor, or by a person designated by the ship’s master who is trained in the administration of the tests.

Full records of testing must be kept and made available to the Chief Medical Officer, via Customs and Immigration, in order for a quarantine reduction to be granted. If any person onboard does not consent to testing, then no person onboard will be eligible for a quarantine reduction.

In order for a vessel to opt for the “5-day test to release”, all persons onboard must provide proof to the vessel’s Master that they have completed the full course of a vaccination.

The vaccination course must be fully completed at least 2 weeks before the period of quarantine begins for persons on board the ship. The vaccine must be approved by the Medicines and Healthcare products Regulatory Agency (MHRA). See this link for more information <https://www.gov.uk/guidance/covid-19-vaccines-if-you-live-abroad#regulatory-information-on-vaccines-authorised-in-the-uk> The vessel’s Master will be responsible for checking the vaccination documentation, and providing evidence when requested by the Chief Medical Officer (via Customs and Immigration).

If all persons are fully vaccinated and agree to testing, the vessel can opt for “5-day test to release”. If it is intended that persons start their period of quarantine at sea, tests should be administered by the ship’s doctor or designated person on or before the second day after departure from the last port prior to arrival in the Falklands, and repeated on day 5. Only after all persons who began their period of quarantine on board the vessel and have tested negative in both tests (or are a convalescent case), will the quarantine reduction be granted.



If any person onboard does not meet the vaccination criteria, the vessel may opt for “8-day test to release”. In this case the initial tests will be administered on or before the second day after departure from the last port prior to arrival in the Falklands with a second test on day 8.

As with 5-day testing, if anyone tests positive in either test (unless they are a convalescent case), then all persons onboard may be required to complete 10-day self-isolation from the date of the positive test result.

A convalescent case is a person who is able to provide evidence that they were infected by coronavirus not more than 90 days before the day of departure and who meets one of the following criteria:

- (a) the person has had no symptoms of coronavirus and is able to evidence that they were infected by coronavirus at least 14 days before the day of departure; or
- (b) the person has had no symptoms of coronavirus for a period of 4 days ending on the day of departure, and is able to provide evidence that they were infected by coronavirus at least 10 days before the day of departure.

The Master must provide evidence to the Chief Medical Officer (via Customs and Immigration) which enables her to be satisfied that an individual is a convalescent case.

If persons disembark part way through the quarantine period for the purposes of completing quarantine ashore, then the relevant test or tests will be conducted by KEMH staff in line with the process provided in the guidance for persons quarantining ashore. All persons remaining on the vessel will still have to fully comply with the test to release program, and all persons will be treated as a single group in the event of a positive test for a person either still onboard or ashore.

A person may not leave quarantine on the basis of the test and release programme until they have been informed by the Chief Medical Officer that they qualify for early release. In the case of persons on board a vessel, this will ordinarily be communicated via Customs and Immigration to the Master, who is responsible for advising persons on board.

### **Arrival of vessels where quarantine has not been completed**

The Master of a vessel who has persons on board who cannot claim a full exemption from the period of quarantine and who intend to link with the shore to either land or take on crew (including crew who are receiving medical treatment), stores or bunkers, should -

1. Contact the Customs and Immigration Service at least 24 hours prior to arrival on [shipsclearance@customs.gov.fk](mailto:shipsclearance@customs.gov.fk) and,
2. Send a copy of the vessel's risk assessment and proposed working practices showing how persons on board will
  - a. Use PPE
  - b. Maintain physical distancing



### **Activities on a vessel that is a place of quarantine**

The law does not prevent any work that can be carried out on a ship or between ships or between a ship and the harbour, even if the persons on board ship are in quarantine, provided that they comply with the quarantine requirements.

It is very important that all activities are subject to proper risk assessment and risk management by the vessel and an example of one approach is included at the end of this document.

Large scale cargo movements between vessels and transhipments should be avoided because of the risk of crew injury and the limited medevac capability in the Falkland Islands.

### **Arrival documents**

#### **CD-19 Non-Essential Visitors' Application Form 2021**

In addition to the routine Customs and Immigration reporting formalities, all those arriving in the Falklands Islands who

- expect to stay for more than a brief shore leave not involving overnight accommodation landside; or
- are travelling here as part of a crew exchange or repatriation;

must complete a [CD-19 Non-Essential Visitors' Application Form](#) for submission to Customs and Immigration

#### **IDC5 Information relating to quarantine 2021**

Everyone who arrives in the Falkland Islands **must** provide information about themselves, about their journey and about the arrangements they have made to stay in quarantine. The information must ordinarily be provided 72 hours before arrival in the Falkland Islands, and is usually completed on Form ICD-5 for those coming ashore. This is to help the Falkland Islands Government manage the quarantine requirement. This is a mandatory requirement under regulations.

For these purposes, a vessel is considered to arrive in the Falkland Islands on crossing the reporting line to the relevant port of entry.

A person travelling on a commercial transport service (including cruise ships) must provide the information to the operator of their service not less than 72 hours before arrival. The operator is then responsible for passing the information to the Chief Medical Officer. A person travelling on any other service is responsible for providing the information to the Chief Medical Officer 72 hours before arrival. The vessel's Master may, in either case, discharge these duties by providing the information to the Chief Medical Officer via Customs and Immigration.

The duty to provide the information 72 hours before arrival does not apply in limited cases, including in relation to:



(a) a person arriving from sea to obtain medical assistance ashore; or

(a) a person arriving on a clean vessel.

In these instances, the person must provide the information on arrival (and it is anticipated that the vessel's Master will provide the information to Customs and Immigration on arrival).

Failure to provide the information required by the Regulations is an offence, punishable by a fine of up to £2000 or a term of imprisonment of up to 3 months.

### **Covid-19 Pandemic Special Measures Additional Reporting Requirements Form**

All ships' operators are expected to complete this multi-purpose form. The completed form provides Customs and Immigration with all the information needed to establish whether a ship can be regarded as a "clean vessel" under the Exemptions Direction, so that all persons on board are exempt from the requirement to stay in quarantine for 10 days after arriving in the Falkland Islands.

### **Submitting relevant documents and returning completed forms**

In summary, all vessels should send copies of relevant documents and completed forms to the Customs and Immigration Service on; [shipsclearance@customs.gov.fk](mailto:shipsclearance@customs.gov.fk) as follows:

Test to Release records and documentation for Chief Medical Officer	On completion of Test to Release periods, being either on Day 5 or Day 8 or when requested by the Chief Medical Officer. It is for the CMO be satisfied that all requirements are met prior to approving early release from quarantine.	
Risk Assessments and Proposed Working Practices in respect of intended activities by vessels that are a place of quarantine	At least 24 hours in advance of intended arrival	
CD19 Forms	In advance of arrival if possible and not later than when submitting ship's Customs Inwards Reporting documentation	
IDC5 Forms	Commercial transport (Including cruise ships) or of a person travelling on any other service :  At least 72 hours in advance of intended arrival*	* The 72 hours in advance requirement does not apply in respect of persons arriving to obtain medical assistance on shore or persons arriving on a clean vessel, but the required information must be provided on arrival.





		For crew and passengers not disembarking other than for brief shore leave not involving overnight accommodation on shore the prescribed Customs crew and passenger lists may be utilised in lieu of IDC5 forms. However for crew or passengers who are disembarking and not returning to their vessel, IDC5 forms <u>must</u> be provided in respect of those persons.

### **Additional requirements for Fishing Vessels**

All fishing vessels must submit the relevant completed letter to the Fisheries Department on each and every occasion they are entering the Falkland Islands Fisheries Conservation Zones: [fishops@naturalresources.gov.fk](mailto:fishops@naturalresources.gov.fk)

A copy of this letter can be found in the COVID Guidance to Fishing Vessels available from the Department of Natural Resources.

### **Additional requirement for expedition vessels**

In addition to other requirements laid out in this Guidance Document, expedition vessel operators wishing to travel to the Falkland Islands must also comply with a further set of conditions including those related to onboard hygiene, pre-voyage PCR testing, limits on the numbers of passengers onboard, medevac provision and insurance.

Cruise ship operators who wish to travel to the Falkland Islands must provide a certificate of compliance with the required conditions, providing details of their journey.



Completed certificates should be submitted as soon as operators have identified prospective journey dates but operators are advised to allow at least 30 days in advance of finalization of voyages in order to allow sufficient time for responses to be provided by the operator to potential follow up information requests and for subsequent decisions to be made by FIG.

The Master of the Expedition Vessel will be required to produce a similar Certificate when the vessel arrives at its first port of call in the Falkland Islands.

If persons are quarantining on a ship no shore leave is permitted. Any person who arrives in the Falkland Islands is subject to quarantine requirements in accordance with the Infectious Diseases Control (Coronavirus: International Travel, Operator Liability and Quarantine) Regulations 2021.

**PERSONS ARRIVING IN THE FALKLAND ISLANDS BY AIR OR BY SEA MUST PROVIDE THE INFORMATION BELOW AS FOLLOWS:**

**If you are travelling on a commercial transport service (see NOTE 1):**

**You must provide the information to the operator of the service not less than 72 hours before your arrival; OR**

**You must provide the information on arrival if you are a person described in NOTE 2**

**If you are travelling on any other transport service:**

**You must provide the information to the Chief Medical Officer not less than 72 hours before your arrival (see NOTE 3); OR**

**You must provide the information on arrival, if you are a person described in NOTE 2.**

**If you have booked your flight less than 72 hours before your arrival, you must provide the information as soon as possible**

**If your sea voyage has commenced less than 72 hours before your arrival, you must provide the information as soon as possible.**

**If you are responsible for a child who is arriving in the Falkland Islands then you must provide the information on their behalf**

**If you are air crew or vessel crew, see NOTE 4**

### **WARNING**

**If you fail to provide the information required, you may commit a criminal offence under the Infectious Diseases Control (Coronavirus, International Travel, Operator Liability and Quarantine) Regulations 2021 for which you can be fined up to £2000 or imprisoned for up to 3 months**

**NOTE 2:** You do not need to provide the information 72 hours in advance, and must only provide the information on arrival if:

- (a) you are a Crown servant (this means UK civil servants and members of the armed forces)
- (b) you are exempt from the requirement to spend any time in quarantine in the Falkland Islands;
- (c) you are a person arriving from sea to obtain medical assistance; or
- (d) you arrived on a “clean” vessel.

A clean vessel is a vessel that –

- (i) has been at sea for more than 10 consecutive days;
- (ii) during the period at sea has not arrived in any place other than Ascension Island, British Antarctic Territory, South Georgia and the South Sandwich Islands, St Helena or Tristan da Cunha;
- (iii) during the period at sea has not reported any person as showing symptoms of coronavirus; and
- (iv) during the period at sea has only been boarded by persons from, and passengers or members of the crew have only boarded, other vessels that meet the criteria in paragraphs (i)-(iii);

**NOTE 4:** If you are aircrew you are treated as arriving in the Falkland Islands if you come landside.

If you are on a vessel you are treated as arriving in the Falkland Islands if you cross the reporting line for the relevant port of entry.

**NOTE 5:** You may give more than one address as your place of quarantine if

- (a) you are under a legal obligation to change accommodation during the period of quarantine;
- (b) it is necessary, before travelling to your place of quarantine, to stay overnight at other accommodation; or
- (c) the first address is the ship on which you arrived in the Falkland Islands and you intend to move to an address on land to complete the period of quarantine.
