Overall Purpose of the Role

The role of the Offshore Petroleum Environmental Inspector is diverse and involves all aspects associated with the regulatory inspection and enforcement of oil and gas environmental legislation in the Falkland Islands.

Joining the Department of Mineral Resources (DMR) team, you'll provide expert input into the investigation and inspection of onshore and offshore petroleum installations situated in the Falkland Islands. The role involves responding to environmental incidents and regulatory non-compliance events and maintaining and participating in an effective 24/7 response capability.

In an evolving and dynamic area for the Falkland Islands, you will also contribute to the development of industry guidance, standards and operational strategy.

Capable of working under challenge and pressure, you will have the interpersonal skills needed to build robust relationships with internal and external stakeholders, and to influence organisational change to encourage, improve and enforce compliance with environmental regulation.

Key Role Activities

The post holder will be responsible for reviewing and assessing all submissions from an environmental perspective for offshore petroleum developments. This will include the review of (but is not limited to):

- Operator submissions of environmental impact assessments including reviewing and ensuring any mitigation measures are being deployed;
- Operator submissions of applications for geographical surveys for suitability;
- Operator submissions of notifications for drilling and well interventions for suitability;
- Operator submissions of notifications for drilling and well interventions for suitability;
- · Operator submissions of Decommissioning Plans for suitability;
- All other relevant notifications associated with an operational petroleum development.

The post holder will be also be required to:

- Carry out inspections of on-shore and off-shore facilities and installations associated with the offshore petroleum industry to ensure environmental compliance including the identification of risks and regulatory non-compliances.
- Undertake enforcement action as required for regulatory non-compliances; Participate in an on-call
 incident response rota and liaise with relevant stakeholders for any emergency response to an
 environmental, marine operation or aviation incident (ERMA);

Key Role Activities continued

- Prepare technical reports and if required, providing expert evidence and acting in an expert witness capacity to any environmental related non-compliances or emergency response marine operation or aviation (ERMA) incident associated with the offshore petroleum industry;
- Where environmental non-compliances or ERMA incidents have occurred, undertake root cause analysis
 to ensure that lessons are learned. This includes working collaboratively with relevant stakeholders to
 ensure any lessons learned are implemented as required;
- Provide technical and expert guidance to colleagues, industry representatives, and other stakeholders on environmental matters related to the offshore petroleum industry;
- Contribute to industry safety improvements by providing expert advice for the shaping and development of regulatory policy and legislation, including contributing to the development of associated regulations and codes of practice;
- Contribute to the design and delivery of training programmes to ensure compliance against identified standards
- Represent DMR on industry working groups and maintain effective liaison with other Government departments and non-government organisations on environmental issues;
- Deputise for the Offshore Petroleum Environmental Manager as required;
