Republic of Belarus (Sanctions) (Overseas Territories) Order 2020 (SI 2020/1271)

Airport Operators (Republic of Belarus, Sanctions) Direction 2022

In exercise of the powers conferred by regulation 29A(5) of the Republic of Belarus (Sanctions) (EU Exit) Regulations (SI 2019/600), as applicable under the Republic of Belarus (Sanctions) (Overseas Territories) Order 2020, I direct as follows:

1. Title and commencement

- (1) This direction is the Airport Operators (Republic of Belarus, Sanctions) Direction 2022.
- (2) This direction comes into force on publication in the Gazette.

2. Direction to instruct operators or pilots

Airport operators are directed to refuse permission for Belarusian aircraft to land at an airport.

3. Exceptions

(1) Airport operators are not required to comply with the direction in paragraph 2 where any of the conditions in subparagraphs (2) to (4) are met.

- (2) The condition in this subparagraph is satisfied if granting permission to a Belarusian aircraft to land is reasonably necessary to secure
 - (a) the safety and security of the aircraft or a person on board:
 - (b) the safety and security of other aircraft; or
 - (c) the safety of any person on the ground.
- (3) The condition in this subparagraph is satisfied if, in accordance with Article 5 of the Chicago Convention, the Belarusian aircraft which seeks permission to land is
 - (a) engaged in non-scheduled international air services; and
 - (b) exercising, or intends to exercise, its right to land in the Falkland Islands for non-traffic purposes.
- (4) The condition in this subparagraph is satisfied if an airport operator has been instructed by the Governor that a Belarusian aircraft requires permission to land at an airport for humanitarian or diplomatic reasons.

4. Interpretation

(1) In this direction —

"airport" means the aggregate of the land, water, buildings and works comprised in an aerodrome within the meaning of article 3(1) of ANOTO;

"airport operator" means a person in charge of an airport;

"ANOTO" means the Air Navigation (Overseas Territories) Order 2013 (SI 2013/2870); and

"the Chicago Convention" means the Convention on International Civil Aviation and its Annexes, signed in Chicago on 7 December 1944, as amended.

(2) Unless the contrary intention appears, words in this direction have the meaning given in the Republic of Belarus (Sanctions) (EU Exit) Regulations 2019 as modified by the Republic of Belarus (Sanctions) (Overseas Territories) Order 2020.

Explanatory Note

(This note is not part of the direction)

This direction is addressed to all airport operators under regulation 29A(5) of the Republic of Belarus (Sanctions) (EU Exit) Regulations 2019 (SI 2019/600, "the Regulations"), as applied to the Falkland Islands in modified form by the Republic of Belarus (Sanctions) (Overseas Territories) Order 2020 (SI 2020/1271).

The direction requires all airport operators in the Falkland Islands to refuse to give clearance to land to a Belarusian aircraft (subject to exceptions in paragraph 3).

Failure to comply with this direction is an offence under regulation 29D(2) of the Regulations.

Republic of Belarus (Sanctions) (Overseas Territories) Order 2020 (SI 2020/1271)

Air Traffic Control (Republic of Belarus, Sanctions) Direction 2022

In exercise of the powers conferred by regulation 29A(3) of the Republic of Belarus (Sanctions) (EU Exit) Regulations 2019 (SI 2019/600), as applicable under the Republic of Belarus (Sanctions) (Overseas Territories) Order 2020, I direct as follows:

1. Title and commencement

- (1) This direction is the Air Traffic Control (Republic of Belarus, Sanctions) Direction 2022.
- (2) This direction comes into force on publication in the Gazette.

2. Direction to air traffic control

- (1) Air traffic control is directed to direct the operator or pilot of a Belarusian aircraft that
 - (a) the aircraft is not permitted to enter Falkland Islands airspace; or
 - (b) where the aircraft has entered Falkland Islands airspace, that it is required to leave Falkland Islands airspace by such route as air traffic control may specify.

3. Exceptions

- (1) Air traffic control is not required to comply with the direction in paragraph 2 where any of the conditions in subparagraphs (2) to (4) are met.
- (2) The condition in this subparagraph is satisfied if the instruction air traffic control provides to the operator or pilot of a Belarusian aircraft is reasonably necessary to secure
 - (a) the safety and security of the aircraft or a person on board;
 - (b) the safety and security of other aircraft; or
 - (c) the safety of any person on the ground.
- (3) The condition in this subparagraph is satisfied if, in accordance with Article 5 of the Chicago Convention, the aircraft which air traffic control is instructing is
 - (a) engaged in non-scheduled international air services; and
 - (b) exercising, or intends to exercise, its right to over fly or land in the Falkland Islands for non-traffic purposes.
- (4) The condition in this subparagraph is satisfied if air traffic control has been instructed by the Governor that an aircraft requires access to Falkland Islands airspace for humanitarian or diplomatic reasons.

4. Interpretation

(1) In this direction—

"air traffic control" means any person who provides any of the following services in the Falkland Islands —

- (a) an air traffic control service (which has the meaning that it has in article 3(1) of ANOTO); or
- (b) a flight information service (which has the meaning that it has in article 3(1) of ANOTO);

"ANOTO" means the Air Navigation (Overseas Territories) Order 2013 (SI 2013/2870); and

"the Chicago Convention" means the Convention on international Civil Aviation and its Annexes, signed in Chicago on 7th December 1944, as amended.

(2) Unless the contrary intention appears, words in this direction have the meaning given in the Belarus (Sanctions) (EU Exit) Regulations 2019 as modified by the Republic of Belarus (Sanctions) (Overseas Territories) Order 2020.

This direction is addressed to all air traffic controllers under regulation 29A(3) of the Republic of Belarus (Sanctions) (EU Exit) Regulations 2019 (SI 2019/600, "the Regulations"), as applied to the Falkland Islands in modified form by the Republic of Belarus (Sanctions) (Overseas Territories) Order 2020 (SI 2020/1271).

The direction requires all air traffic controllers in the Falkland Islands to direct a pilot or operator of a Belarusian aircraft that they are not permitted to enter, or must leave, Falkland Islands airspace (subject to the exceptions in paragraph 3).

Failure to comply with a direction given by air traffic control in accordance with this direction is an offence under regulation 29D(3) of the Regulations.

Retail Prices Index

The Retail Prices Index for the quarter ended 30 September 2021 has now been completed.

The Index has increased by 0.9% to 107.227. The change in the Index over the year to 30 September 2021 has been +2.8%.

There is no evidence of inflation in the "Food and nonalcoholic beverages" category; changes in prices in this category contributed with -0.2 percentage points to quarterly inflation and prices are unchanged when compared to one year ago. "Fuel and power" contributes with +0.4 percentage points to quarterly inflation and +0.6 percentage points to annual inflation, mainly driven by an increase in the price of electricity (+0.4 percentage points both at quarterly and annual level). The case of electricity is a clear example of the impact on the Index of "base effects": there is a growth in the price of electricity (+15% compared to both the previous quarter and the same quarter of the previous year) because a significant decrease was recorded in 2020; the price of electricity has in fact now returned to its pre-Covid-19 level (23p per unit).

Comparing the Index with its level two years ago helps circumvent the impact of "base effects" due to the 2020 deflationary shock. The Retail Prices Index is 1.1% higher in Quarter 3 of 2021 than in the same quarter in 2019 -corresponding to an annualised rate of growth of +0.6%. This is consistent with the rate of growth that the Index has experienced before the Covid-19 shock, +0.8% per year between Quarter 1 in 2014 and Quarter 1 in 2020.

Retail Prices Index

The Retail Prices Index for the quarter ended 31 December 2021 has now been completed.

The Index has increased by 1.5% to 108.853. The change in the Index over the year to 31 December 2021 has been +4.8%.

The rise in fuel and power prices (including vehicle fuel) explains more than half of the annual change in inflation. Fuel and power prices are also the main contributors to quarterly inflation. On the other hand, at the moment there is no evidence of inflation in the "Food and non-alcoholic beverages" category.

The data points to an acceleration of price growth compared to previous quarters; although much of the year-over-year growth can be attributed to "base effects" on fuel prices (that is fuel price inflation today is mainly due to low fuel prices recorded a year ago, in the aftermath of the Covid-19 shock). Comparing the Index with its level two years ago helps

circumvent the impact of "base effects" due to the 2020 deflationary shock. The Retail Prices Index is 2.7% higher in Quarter 4 of 2021 than in the same quarter in 2019 -corresponding to an annualised rate of growth of +1.3%.
