### Retail Prices Index

The Retail Prices Index for the quarter ended 30 June 2022 has now been completed.

The Index has increased by 0.4% to 111.168. The change in the Index over the year to 30 June 2022 has been +4.6%.

The data points to a marginal increase in price growth compared to previous quarters; much of the year-over-year growth is attributed to base effects on fuel prices (i.e. low fuel prices recorded one year ago) in addition to continued price growth in food and non-alcoholic beverages. However, the effects of those increases are offset by a decrease in the cost of household and services.

In contrast to the second half of 2021, the evidence of inflation in the "Food and non-alcoholic beverages" category witnessed in the first quarter of 2022 is again observed for the second quarter. Changes in prices in this category for quarter 2 of 2022 contributed +0.5 percentage points to quarterly inflation and +1.0% to annual inflation.

The rise in fuel and power prices (including vehicle fuel) has had a strong impact on quarterly inflation in contrast to the preceding quarter, as price growth in that category has increased beyond the rebalancing effects witnessed throughout 2021. Prices for kerosene have returned to a level consistent

with those prevailing before the Covid-19 shock, however diesel prices have risen sharply and exceed those observed prior to 2021; diesel fuel contributed +0.8 percentage points to quarterly inflation and +1.5 percentage points to annual inflation.

However, the -0.8 percentage points decrease observed in "all other items" had the effect of offsetting the impact on quarterly inflation of price growth in the fuel and power and food and non-alcoholic beverages categories.
