Education (Governance and Accountability) (Functions of College Advisory Committee) Regulations 2022

ARRANGEMENT OF PROVISIONS

Education (Governance and Accountability) (Functions of College Advisory Committee) Regulations 2022

I make these Regulations under section 32 of the Education (Governance and Accountability) Ordinance 2022, after consulting the Board and the Director on the advice of Executive Council.

1. Title

These Regulations are the Education (Governance and Accountability) (Functions of College Advisory Committee) Regulations 2022.

2. Commencement

These Regulations come into force on publication in the *Gazette*.

3. Amendment to Schedule 3 of the Education (Governance and Accountability) Ordinance 2022

- (1) These Regulations amend Schedule 3 (College Advisory Committee) to the Education (Governance and Accountability) Ordinance 2022.
- (2) In paragraph 1
 - (a) in subparagraph (a), after "Falkland College" insert ", the national library service";
 - (b) after subparagraph (b) insert
 - "(bA) management of the national library service is of a high standard and the service meets the needs of users;"
 - (c) in subparagraph (c), after "staff" insert ", national library service users";
 - (d) in subparagraph (d), after "students" insert "and national library service users"; and
 - (e) in subparagraph (e), after "Falkland College", in both places where it appears, insert "and the national library service" and replace "was" with "were".
- (3) In paragraph 3(c)
 - (a) after sub-subparagraph (i) insert
 - "(iA) a person representing users of the national library service;".

(b) in sub-subparagraph (ii), after "Falkland College" insert "or in the national library service".

EXPLANATORY NOTE

(not forming part of these Regulations)

These Regulations are made under section 32 of the Education (Governance and Accountability) Ordinance 2022, after consultation with the Board of Education and the Director of Education. They amend Schedule 3 of the Ordinance to add strategic oversight of the national library service to the functions of the College Advisory Committee and provide for the appointment of a person representing library service users to the Committee.

The College Advisory Committee ("**the Committee**") is a committee of the Board of Education, whose primary function is strategic oversight of Falklands College. The Regulations come into force on publication in the *Gazette*. The Regulations reflect the fact that the Director of Education has, in exercise of powers under section 17 of the Ordinance, designated a college leader, namely the College Development Manager, to be responsible for the national library service.

Regulation 3(2) adds the duty to advise the College Development Manager to the list of functions of the Committee set out in Schedule 3(1) to the Ordinance.

The duty must be exercised with a view to ensuring that —

- management of the national library service is of a high standard and the service meets the needs of users;
- the College Development Manager engages with users in a consistent and effective manner;
 and
- resources available for the library are used efficiently and effectively to support the purposes
 for which the library service was established. Those purposes are set out in section 16 of the
 Ordinance.

To enable these new functions to be discharged, regulation 3(3) enables a representative of library users to be appointed to the committee.

Customs Resolution 2022

(No. 6 OF 2022)

Customs Resolution 2022

(made: 27 May 2022) (commencement: in accordance with paragraph 2) (published: 31 May 2022)

The Legislative Assembly hereby resolves that —

1. Title

This Resolution is the Customs Resolution 2022.

2. Commencement

This Resolution comes into effect on the day after the resolution is made.

3. Customs duties increased

For the purposes of —

- (a) section 113(1) of Customs Ordinance 2003 ("**the Ordinance**"), the duty charged on the importation into the Falkland Islands of
 - (i) cigars is £441.05 per kilogram;
 - (ii) cigarettes is £475.08 per kilogram; and
 - (iii) tobacco is £318.29 per kilogram.
- (b) section 124(1) of the Ordinance, the prescribed duty on spirits imported into the Falkland Islands is £14.67 per litre;
- (c) section 127(1) of the Ordinance, the prescribed duty on beer (including cider) imported into the Falkland Islands is £0.39 per litre;
- (d) section 128(1) of the Ordinance, the prescribed duty on wine imported into the Falkland Islands is £0.97 per litre;
- (e) section 129(1) of the Ordinance, the prescribed duty on spirituous beverages imported into the Falkland Islands is £7.87 per litre;
- (f) section 130(1) of the Ordinance, the prescribed duty on fortified wine imported into the Falkland Islands is £1.15 per litre; and

(g) section 131 of the Ordinance, the prescribed duty on other strong liquor imported into the Falkland Islands that is not spirits, beer, wine, spirituous beverages or fortified wine within the meaning of the Ordinance, is £1.15 per litre.

EXPLANATORY NOTE (not part of the Resolution)

This Resolution is made by Legislative Assembly to prescribe the duties payable under Part X of the Customs Ordinance 2003 (imposition of duty and relief and exemption from duty) on the importation of alcoholic beverages and tobacco and tobacco products into the Falkland Islands.

With effect from the day after the resolution is made, the duty payable is increased as follows —

on cigars from £420.05 to £441.05 per kilo; on cigarettes from £452.46 to £475.08 per kilo; on tobacco from £289.35 to £318.29 per kilo; on spirits from £14.24 to £14.67 per litre; on beer (including cider, perry etc) from 38p to 39p per litre; on wines (both still and sparkling) from 94p to 97p per litre;

on spirituous beverages from £7.64 to £7.87 per litre; and

on fortified wines from £1.12 to £1.15 per litre.

A duty of £1.15 per litre will also for the first time be imposed on the importation of other strong liquor. "Other strong liquor" is an alcoholic beverage that is not spirits, beer, wine, spirituous beverages or fortified wine within the meaning of the Ordinance i.e. it contains more than 12% alcohol by volume but less than 22% alcohol by volume.
