Retail Prices Index

The Retail Prices Index for the quarter ended 30 September 2023 has now been completed.

The Index has increased by 1.2% to 123.222. The change in the Index over the year to 30 September 2023 has been +8.3%.

Following the apparent temporary moderation of inflation rates during the first quarter of the year, and the subsequent reversal of those effects in quarter 2, inflation remains persistently elevated for the third quarter of 2023. The bulk of the quarterly growth is attributed to continued increases in the food and non-alcoholic beverages category; however, the relative contribution from this class is somewhat lower than previously observed over the year to date. The surprise quarter 2 uptick in 'recreation and culture' price growth has continued into quarter 3, with that category remaining the second highest contributor to quarter 3 inflation.

Despite the current plateau in fuel and power prices, much of the year-on-year growth is attributed to the sustained and substantial price growth in fuel, including vehicle fuel and power.

Evidence of inflation in the 'Food and non-alcoholic beverages' category is again obvious for quarter 3 of 2023, contributing $\pm 0.4\%$ to quarterly inflation and $\pm 2.2\%$ to annual inflation, and continuing the trend witnessed over the past year.

Following the recent decline, and now the current holding of commodity prices, the price growth recorded in 'Fuel and power', is markedly less dominant compared to the previous three quarters; contributing 0.0% to quarterly inflation and +4.5% to annual inflation. (Note that vehicle fuel is recorded under 'transport', rather than 'fuel & power'). Electricity price growth contributed +1.4% to annual inflation, compared with +2.2% in the first quarter of 2023 (+2.3 in quarter 4 of 2022), while the quarter-on-quarter growth continues unchanged for quarter 3 of 2023. It is clear that the peaks witnessed in kerosene and diesel fuel prices in the last quarter of 2022 have softened. The kerosene sub-index (year-on-year)

is holding at +57% higher than the quarter 3 of 2022 price, while the diesel sub-index (year-on-year) sustains its foray into negative territory with a -24% gain on the price 12 months
