Building Designation (Stone House, New Island) Order 2023

(made: 10 July 2023) (coming into force: on publication) (published: 31 July 2023)

I make this order under section 65(1) of the Planning Ordinance 1991 ("the Ordinance") —

- (a) on the advice of the Executive Council; and
- (b) on the recommendation of the Planning and Building Committee (composed under section 63(1) as required by section 65(2)(b) of the Ordinance).

1. Title

This order is the Building Designation (Stone House, New Island) Order 2023.

2. Commencement

This order comes into force on publication in the Gazette.

3. Designation of Stone House, New Island

- (1) The building on New Island specified in the Schedule is designated as a building of special architectural and historic interest.
- (2) The designation relates to the building in respect of both its external appearance and internal features.

SCHEDULE

(article 3)

The building known as "Stone House", located approximately 250 metres north of the main cluster of buildings on New Island and approximately 250 metres south of the Barnard Memorial Museum.

EXPLANATORY NOTE (not part of the order)

This Order is made under section 65(1) of the Planning Ordinance 1991 on the recommendation of the Planning and Building Committee composed in accordance with section 63(1) of the Ordinance. This order is for the designation of the building known as the Stone House on New Island.

AN ORDINANCE

To authorise the appropriation from the Consolidated Fund of the additional amount of £2,656,000 for the financial year ending 30 June 2023.

ENACTED by the Legislature of the Falkland Islands —

1. Title

This Ordinance is the Supplementary Appropriation (2022-2023) Ordinance 2023.

2. Commencement

This Ordinance comes into force on publication in the Gazette.

3. Appropriation

- (1) The additional amount of £2,656,000 is appropriated from the Consolidated Fund for the financial year ending 30 June 2023.
- (2) The issue of the additional amount from the Consolidated Fund in the amounts necessary to replace an amount in accordance with section 4 and to supply the votes set out in the Schedule is authorised.

4. Replacement of amount withdrawn by authority of Contingencies Warrant

If an amount has been withdrawn from the Contingencies Fund by the authority of a Contingencies Warrant, the amount withdrawn must be replaced from the amount appropriated under section 3.
