NOTES TO ELECTORAL FORM V

Note 1 “Citizen”

means a British citizen, a British Overseas Territories citizen or a British Overseas citizen.

Note 2 “Falkland Islands Status”

has the meaning given to it by section 22(5) of the Falkland Islands Constitution. If you are unsure whether you or a relevant person has Falkland Islands status, please contact the Customs and Immigration Department on 27340.

Note 3 “Disqualified from being an elector”

The Constitution states that the following persons are not qualified to be registered as electors:

- a) A person certified to be insane or otherwise judged to be of unsound mind under any law;
- b) A person who is serving a sentence of imprisonment for a term exceeding 12 months;
- c) A person disqualified by law from being registered as an elector by reason of having been convicted of an offence relating to elections;
- d) Members of H.M. regular Armed Forces; unless he or she has Falkland Islands Status (members of the Falkland Islands Defence Force are not regarded as members of H.M. regular Armed Forces);
- e) A person who is, by virtue of his or her own act, under any acknowledgement of allegiance, obedience or adherence to a foreign power or state.

Note 4 “Temporarily Absent”

For the purpose of deciding whether a person is to be treated as living at a particular address but is temporarily absent from it:

- a) a person staying temporarily at an address, whether in the Falkland Islands or elsewhere, will not usually be taken to be living there if he has a permanent home elsewhere;
- b) a person staying temporarily at an address, whether in the Falkland Islands or elsewhere, may be taken to be living there if that person has no other home;
- c) where a person would be living at a particular address in the Falkland Islands but is not living there because of duties arising from employment (whether those duties are carried out in the Falkland Islands or elsewhere), the period of absence will usually be disregarded if the person intends to resume living at the address;
- d) a person’s absence to attend a course provided by an educational institution, whether in the Falkland Islands or elsewhere, will usually be disregarded;
- e) a person detained in legal custody i.e. serving a sentence of imprisonment, whether in the Falkland Islands or elsewhere, will be treated as living at the address the person would otherwise have been living at;
- f) a merchant seaman, who would be living at an address in the Falklands Islands but for their occupation, will be treated as living at the address that the person would otherwise have been living at;
- g) a person remanded in custody e.g. awaiting trial, will be treated as living at the address they would otherwise have been living at if the person intends to resume living there and as if the address is their permanent home.

Note 5 Householder’s Signature

This form must be signed and dated by the person who owns or rents the property, whose signature must be witnessed by:

- A bank manager; a commissioner for oaths; an elector; a justice of the peace; a police officer; a teacher of or tutor to the applicant or another person approved by the Registration Officer

Further IMPORTANT Information:

Under section 11(5) of the Electoral Ordinance a person who is already registered as an elector will lose their entitlement to registration, for example, the form has not been returned by the Monday 17 April 2023, or does not contain enough information. In these circumstances, the person will be removed from the register.
